Maharshi Dayanand Yogashram has been starts for extending its dedicated welfare and development services for the upliftment of the people of Tripura. In the initial stage, to introduce some welfare and developmental activities mainly which focused on Yoga and education together to build a better and healthy future but with time and needs more interested people has linked together to the concept and guided to give it a shape of an institution named as "MAHARSHI DAYANAND YOGASHRAM"(MDY).

The stated initiatives has been led by Yogacharya Biman Chandra Nath and Smt. Ruchi Gupta has taken the necessary guidance from all well-wishers to start and organized initiatives for all-round development of the people children to youths, youths to adult, adults to successful maintenance of family responsibilities and also to acquire both spiritual inputs and living tactics to become a successful person in life.

Shri Nirajan Nath has been understanding the desire and concept and thus donates a piece of land for the establishment of an institution and also the first education institution called Gurukul in the state of Tripura. By getting support from Acharya Balakrishnaaji, Swami Vishwanaji, Mahashay Dharampalaji necessary initiatives were taken by Yogacharya Biman Chandra Nathji for the minimum construction and the establishment of the institution, Ashram and a Gurukul during early 2017.

The local community cooperation and support finally enable the concept to transform into practical and support received from all possible concerns and finally guided to form a group of 10 like minded people for the establishment of the targeted institutions from the local community and thereby taken initiatives to register an institution under Indian Trust Act 1882 at Bilthai, Chandpur, Panisagar of North Tripura district of Tripura state and was formally registered on April 18, 2019.



Since, the establishment and construction works was started during 2017-18 onwards has started the first Gurukul of Tripura at Bilthai, Chandpur and Panisagar together with the establishment of the Maharshi Dayanand Yogashram in the beginning of 2018-19.

To organize its developmental activities, it has decided its future plans and has developed its strategies to organized development action plan initially to cover three major concerns of anybody's life viz.

1- Education

2- Health

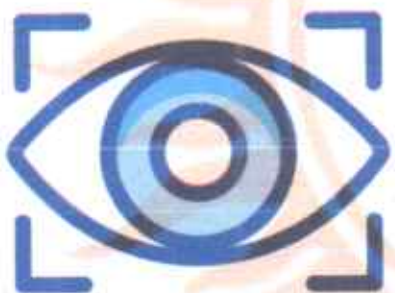
3- Environment

To bring in a new process of development for the local people and community. It also decided to adopt more sectorial activities like livelihoods based on the capacity and available resources for total empowerment of the people of the area and the state.

The Trust has been registered under section 12A of the Income Tax Act, 1961, Govt. Of India and also in the process to obtained its registration under section 80G of Income Tax Act 1961.



To organize people for their social, economic and cultural upliftment with special focuses on promotion of education, health, environment and community development.



To organize planned initiatives for extending welfare and development services to enable people for establishing Gurukul education, health, environment for organized development to enable people for their total empowerment towards leading a progressive life-style.



The major objectives of Maharshi Dayanand Yogashram (MDY) along with latest inclusion of amended objects are as follows:

- Trust can form Gurukul Education system, Yoga Education, Awareness Campaign on Yoga, Protection of Cows and Cattle's maintenance of cows and cattle, cleanliness of environment and its protection, plantation of trees.
- Trust can run a school relating to Vedic System, Sanskrit, English, Hindi, Bengali etc.. medium under CBSE and T.B.S.E. Pattern.
- Trust can form Cultural Centre for the development of culturally talented backward people of villages and make arrangement for regular training and they can also extract financial help to develop their talent by providing awards, scholarships, and financial helps.
- Trust can set up hospitals, primary health centres and boarding house for students, library and vocational training centre for the economic development and can seek help from various Ministries and organizations.

- Trust can set up Ashram and guest house in the service of poor people
- Trust can give money to the poor people of village for constructing their homes and can take appropriate steps to improve their standard of living and for foods and mobile health services for poor people.
- Trust can collect grants from interested kind of people and organizations for managing disasters like earthquake, flood, storm, accident, epidemic etc.
- Trust can accord necessary approval social and religious functions of the economically backward people in the case of its own auditorium.
- Trust can make arrangements for publishing books, leaf plates, and weekly or monthly many magazines for giving appropriate publicity to its regular program and awareness campaign and welfare schemes.
- Trust will give necessary guidance and suggestion in the matter of higher education of the poor students.
- Trust can various scheme of government and private sector meant for helping poor people and implement the scheme.



- Trust can make arrangement of "Bharat Darshan"(Pilgrimage of India) of Pilgrimage out of India for the winning devotees whose are living below poverty line.
- Trust can make arrangements for education and health care for the intelligent and orphan students.
- Trust can take care of neglected old parents and make arrangement of mass marriage of young boys and girls of backward families.
- Trust will try to bring the victims of superstitions , dowry, women harassment , child marriage, women trafficking and drug addicts to the main stream.
- Trust can do charity service by constructing temple in the name of "Arya Samaj Temple" worshipping and making arrangement for offering pranamee donation in the connection with the worship of the God.

The MDV provides its option to starts its charity, welfare and developmental activities in any parts of Tripura by establishing its administrative office any places. The MDV has been established and organizing all its operations from Biltai.

The operations of the Maharshi Dayanand Yogashram (MDY) are mainly focused on the promotion of Vedic education, Sanatan Dharma and to enable the poor, needy rural people inclusive of the tribal people for their total empowerment. It always want to include such people whom are deprived from their due rights and help them in getting development opportunities which are helpful for them in having a peaceful and progressive life style.



EDUCATIONAL PROGRAMS

The main motto of Educational program of the Maharshi Dayanand Yogashram (MDY) is to promote Vedic Siksha by Starting Gurukul Education.

India has always boasted of a rich tradition in the area of learning and education since ancient times. One of the famous educational systems practiced in India in the ancient time was the Gurukul System. The main focus of Gurukuls was on imparting learning to the students in a natural surrounding where the shishyas (students) lived with each other with brotherhood, humanity, love, and discipline. The focus was also given on arts, sports, crafts, singing that developed their intelligence and critical thinking through the group discussions, and self-learning etc.

The Trust has introducing Vedic Shiksha for the students but it has also decided to organize its teaching for all, who are other than students to assist them for learning various aspects of lives to know their rights and to organize them to get within the resource s available our surrounding.

The Trust organize its education programs in two different types of activities as mentioned below :

a-Maharshi Dayanand Arsh Gurukul

b-Student Hostel





The MDY has introduced its education program under the banner of Maharshi Dayanand Arsh Gurukul in 2017. The Gurukul have a hostel for the students to facilitate them to start the dincharya from early morning and thereby learn as per schedules of Gurukul teaching and get added advantages towards adopting integrated approach for self-sustenance by staying away from home and parents guidance for effective learning and their executions in practical of their own lives.



STUDENTS HOSTEL

Maharshi Dayanand Yogashram (MDY) started its Gurukul teaching in September, 2018 on trial basis with three girls and slowly it welcomed more girls to study in Gurukul. Considering the needs and involvements of students from morning to evening to continue their learning and practical, MDY has decided and constructed hostel accommodation for its students.





The main focus of the Health Programs of Maharshi Dayanand Yogashram are on extending its support services to have a strong and healthy society. To ensure this, the MDY has introduced its support and services for organizing health campus, yoga camps, and to take preventive measures to enable common people to keep a healthy community. It observed that , people are spending lots of money and uses their savings for treatments of their family members. It also noticed that, change of habits and adoption of preventive measure which ultimately helped to stop spending on health issues and save their savings.

MDY has decided to guide people to adopt Yoga for their good health and exercise on daily basis may able to develop their personality and help to stay away from all kinds of health disorders. Therefore MDY decided to arrange health awareness generation programs to educate the people of of North Tripura District. And introduce health initiatives in 3 major interventions.

ORGANIZATIONAL STRUCTURE

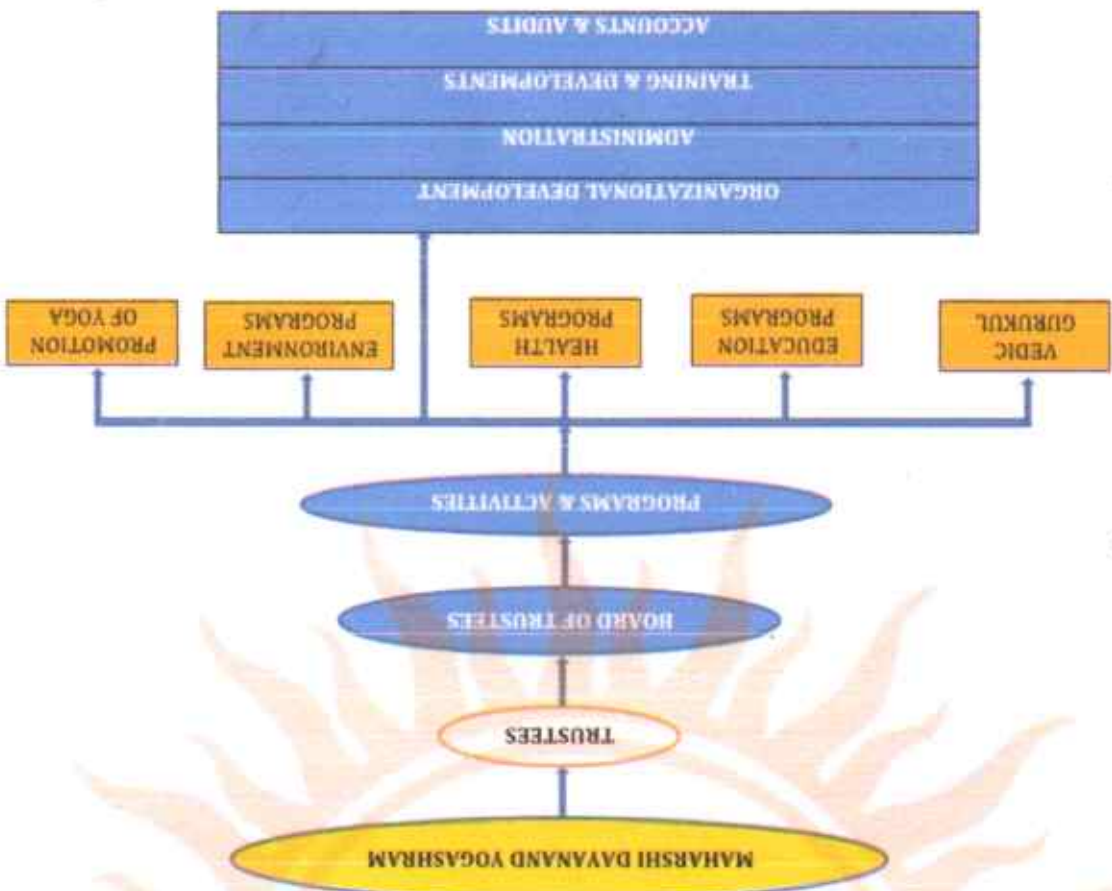
MANAGEMENT:

S.No	Conditions

3	Order in 12AA(10) read with section 12A does not confer any right of exemption upon the applicant in 11 and 12 of Income Tax Act, 1961. Such exemption from tax will be available only after the Assessing Officer is satisfied about the genuineness of the income generated or claimed to be generated in such financial year relevant to the Assessment Year and in the provisions of law stood upon.
